I. Catalog Description

This final section of the four-semester music theory sequence will review large-scale music forms and will cover twentieth and twenty-first century elements, practices, and techniques concerning musical analysis. **Open to all students. Prerequisite: MUSI 2311. Corequisite: MUSI 2117. (3.0).**

II. Course Objectives

Upon satisfactory completion of this course the student will be able to:

- A. Identify, recognize, and analyze music of the Common-Practice period possessing sonata, sonatina, concerto, rondo, sonata-rondo, and large ternary forms.
- B. Identify, recognize, and analyze modes, scales, and sets of music from the twentieth century.
- C. Identify, recognize, and analyze rhythm, meter and form found in music after 1900.
- D. Analyze music of the twentieth century using sets and set classes.
- E. Analyze music of the twentieth century using ordered segments and serialism.
- F. Analyze rhythm, meter, and form found in music after 1945.
- G. Recognize and identify recent trends in music analysis.

III. Evaluation

- A. Examinations, quizzes, and homework assignments will be given throughout the semester. A final comprehensive examination will be given at the end of the semester.
- B. Scores on the tests and final exam will be averaged to fine the percent score for the course. Percent scores will be converted to letter grades according to the following scale:

90-100 = A 80-90 = B 70-80 = C 60-70 = DBelow 60 = F
