I. **Catalog Description**

Develops skills in the concepts, procedures, and application of spreadsheets for business. This course is designed to be repeated multiple times to improve student proficiency. The adopted book maps the technical skills needed to take the Microsoft Office Specialist (MOS) certification exam. The MOS exam is a global certification that validates students' skills. To be certified, an exam must be taken from a third-party testing company. **(3:1)**.

II. **Course Objectives**

- A. Describe and demonstrate how to use OneNote, SWAY, and Office Mix.
- B. Illustrate the current version of Microsoft's operating system.
- C. Identify Apps in Office.
- D. Save and retrieve files from OneDrive.
- E. Identify components of the Microsoft Office Ribbon.
- F. Create folders in a storage location.
- G. Perform tasks using Microsoft Office Apps.
- H. Use the Help function.
- I. Create and format a worksheet and a chart.
- J. Enter formulas, function and formatting values.
- K. Apply functions using AVERAGE, MAX, and MIN.
- L. Formatting the worksheet by apply a theme and selecting an online theme.
- M. Apply the Conditional Formatting command to a range of cells.
- N. Display formulas and print the workbook, formulas, and chart.
- O. Apply absolute and relative addressing.
- P. Use the IF Function and What-If Analysis for a Data Table and Goal Seek.
- Q. Organize the workbook by sheet tab colors and reordering.
- R. Create cell names and apply formulas using the cell name.
- S. Create, edit, and apply styles to different type of charts.
- T. Protect and hide worksheets and workbooks.
- U. Enable background formula checking.
- V. Create consolidated worksheets and workbooks.

- W. Apply the Date, Time and Round functions.
- X. Create and modify cell styles.
- Y. Create, sort and query a table.
- Z. Use the Criterial and Extract ranges.
- AA. Apply data functions, i.e., DAverage, DCount, Sumif, Countit, Match, and Index.
- BB. Create templates, import data, work with SmartArt, Images and Screenshots.
- CC. Work with Trendlines, PivotTables, PivotCharts, and Slicers.
- DD. Use Formula Auditing to trace precedents and check for errors and solve complex problems.
- EE. Use the Scenario Manager to analyze data and summarize data.
- FF. Add data validation to cells.
- GG. Customize Excel Add-in.
- HH. Use Power Tools and create macros.
- II. Apply Power Pivot to query data and create a relationship to measure data.
- JJ. Use and design the user interface.
- KK. Share and Collaborate worksheets and workbooks.
- LL. Apply track changes to a workbook.
- MM. Use Visual Basic for application for writing codes for commands.
- NN. Preview and Print a workbook.
