I. Catalog Description

Develops skills and techniques required for a comprehensive nursing health assessment within a legal/ ethical framework preparing the student to utilize the nursing process. Designed for re-entry, transfer, and advanced placement students only. Students must be in the nursing program and/or have advanced placement in order to enroll in this course. A grade of "C" or better is required in this course to take the next course. (1:1). Lab fee.

II. Course Objectives

Upon completion of this course, the student will be able to:

- A. Unit I: Provider of Patient-Centered Care
 - 1. Determine the health status and health needs using an assessment tool to collect patient data. (SLO 2)
 - Analyze assessment data to identify problems, formulate nursing diagnoses, goals/outcomes and develop plan of care from a hypothetical patient care situation. (SLO 2)
 - 3. Use information from evidence-based practice in collaboration with patient's family and the interdisciplinary health care team. (SLO 4, SLO 5)
 - 4. Discuss the importance of utilizing therapeutic communication to asset patients in meeting their health needs. (SLO 2)
 - 5. Develop and implement a teaching plan for the patient and the family in a simulated patient care situation. (SLO 1)
 - 6. Discern how "Watson's Theory of Human caring" can be applied to patient care. (SLO 2)
 - 7. Correlate critical thinking problem solving and decision making. (SLO 1)
 - 8. Point out the participation in activities that promote the development and practice of professional nursing. (SLO 3)
 - 9. Outline the physical assessment of the neuro, respiratory, cardiovascular, gastrointestinal, integumentary, musculoskeletal, endocrine, and genitourinary systems. (SLO 2)
 - 10. Analyze how to practice within the professional nursing role and score of practice, to ensure and maintain safe patient care with emphasis on the elderly patient in a simulated patient care situation. (SLO 2, SLO 3)
 - 11. Describe methods of identifying and preventing verbal and psychosocial harm to patients during the health history process and during conduct of physical assessment. (SLO 4)

- B. Unit II. Member of the Health Care Team
 - 1. Compare and contrast health assessment and physical assessment of the young adult and those exhibit by the older adult. (SLO 2)
 - 2. Serve as a health care advocate in monitoring and promoting quality and access to health care for the patient and family. (SLO 5)
 - 3. Assign and delegate nursing care to other members of the health care team based upon an analysis of the health history/physical assessment, in a simulated patient situation. (SLO 5)

- Address the concept of accountability and its relationship to the Nursing Process. (SLO 3)
- 3. In a simulated situation, demonstrate responsibility while conducting a health history/physical assessment, and develop insight through reflexion and self-analysis. (SLO 2)
- 4. Comply with mandatory reporting requirements of Texas Nursing Practice Act, during and after the completion of the Health History/Physical Assessment. (SLO 2, SLO 3)
- 5. Distinguish between ethical and legal aspects pertinent to the registered nurse when performing the health history and physical assessment. (SLO 2, SLO 3)
- 6. Discuss the legal requirements and accurately report and document patient data collected. (SLO 2, SLO 3)
- 7. Outline the nurse's responsibility in preparing the client and the environment when conducting the health history/physical assessment. (SLO 2)

V. Evaluation

A. Proficiency Exam
