I. Course Description

Studies the basic welding techniques using some of the following processes: Oxy-fuel welding (OFW) and cutting, shielded metal arc welding (SMAW), gas metal arc welding (GMAW), flux cored arc welding (FCAW), and gas tungsten arc welding (GTAW). Emphasizes development of basic welding techniques and good joint preparation using low carbon steel. **Includes OSHA 10 safety course, 10 hours of construction safety and fall protection. (3:3). Lab fee.**

II. Course Objectives

- A. Set up welding machines.
- B. Practice basic shop safety.
- C. Identify types of electrodes used in welding processes.
- D. Define various welding and cutting standards.
- E. Demonstrate proper joint preparation techniques.
- F. Complete welds using OXY – FUEL, SMAW, GMAW, and GTAW.

III. THECB Learning Outcomes (WECM)

- 1. Demonstrate machine set-up and complete welds and cutting operations.
- 2. Demonstrate basic shop safety.
- 3. Identify types of consumables used in welding processes.
- 4. Identify various welding and cutting practices.
- 5. Demonstrate proper joint preparation techniques.

IV. Evaluation

The knowledge and skills stated in the objective must be demonstrated by the students in the form of tests and assignments in order to complete the course. Test (50%) and lab assignments (50%) will be averaged, letter grades will be arranged as follows:

Students should be able to compute their grade average anytime during the course. Missed assignments and make-up tests will be given at the discretion of the instructor.
