I. Course Description

Provides advanced topics in GTAW welding, including welding in various positions and directions. Student practice will include low/high carbon steel, stainless steel and aluminum. **Prerequisites: WLDG 1407 and WLDG 1434. (3:3). Lab Fee.**

- b. Describe safety rules and equipment used
- c. Describe the welding parameters in GTAW
- d. Weld various joint designs
- e. Perform visual inspections of welds
- f. Diagnose welding problems

IV. Evaluation

The knowledge and skills stated in the objective must be demonstrated by the students in the form of tests and assignments in order to complete the course. Test (50%) and lab assignments (50%) will be averaged, letter grades will be arranged as follows:
