I. Course Description

Provides advanced topics involving welding of pipe using the shielded metal arc welding (SMAW) process. Includes topics on electrode selection, equipment setup, and safe shop practices. Emphasizes weld positions 5G and 6G using various electrodes. **(3:3). Lab Fee.**

II. Course Objectives

- a. Describe equipment and Safety procedures
- b. Demonstrate proper pipe preparation
- c. Perform 5G and 6G welds using various electrodes

1. Describe equipment and required pipe preparation and perform 5G and 6G welds using various electrodes.

IV. Evaluation

The knowledge and skills stated in the objective must be demonstrated by the students in the form of tests and assignments in order to complete the course. Test (50%) and lab assignments (50%) will be averaged, letter grades will be arranged as follows:
