**I. Catalog Description**

Emphasizes a variety of drawing and sketching methods with special interest for the architectural student: the human figure, architectural interiors and exteriors, architectural texture presentation techniques, landscapes, and cityscapes. Requires outside assignments. **Prerequisite: ARCH 2301. (2:4) Lab Fee.**

**II. Course Objectives**

Upon satisfactory completion of this course, the student will be able to:

- A. Control transparent watercolor wash, and blending of color.
- B. Construct a color wheel from primary colors.
- C. Accomplish aesthetic appeal by a palette of well ordered color relationships.
- D. Draw a quick sketch from slides, photos or prints.
- E. Interpret sketches into different color schemes for increased interest and impact.
- F. Derive their own color palette (scheme).
- G. Understand how color visually affects architectural forms.
- H. Construct drawings of architectural forms within a landscape setting.
- I. Illustrate the following subjects; sky, water, vegetation and the four seasons.
- J. Develop skills using prisma-color pencils and transparent watercolor and limited mixed media.

**III. THECB Learning Outcomes (ACGM)**

Upon successful completion of this course, students will:

- 1. Use freehand drawing skills as a design tool.
- 2. Communicate visually through freehand drawings to explore ideas in site plans, elevations, sections, perspective views, and other architectural graphic conventions.
- 3. Apply key strengths of freehand media and skills in design thinking.
- 4. Use a range of drawing techniques best suited to architectural practice, both as exploratory design tools and for presentations.

**IV. Evaluation**

Project Evaluation grades are based on portfolio review at mid-term and at the end of the semester. The Portfolio includes all working assigned during the semester.
