**I. Catalog Description**

Provides a study of programs for the school age child, including an overview of development, learning environments, materials, activities and guidance techniques. (2:2).

**II. Course Objectives**

Upon satisfactory completion of this course, the student will be able to:

- A. Identify quality criteria areas for school-age childcare programs.
- B. Establish and apply criteria for job descriptions, performance, and performance evaluations for personnel in After-School programs.
- C. Identify and utilize changes in the physical, mental, social, and emotional characteristics of school age children in planning and implementing programs.
- D. Use inclusive practices for school-age children.
- E. Implement skills for dealing with inappropriate behavior.
- F. Develop curriculum strategies that contribute to all aspects of development in the school-age child.
- G. Identify strategies to develop partnerships with families and community in After-School programs.

**III. THECB Learning Outcomes (WECM)**

- 1. Outline growth and development of the school age child.
- 2. Analyze components of school age programs.
- 3. Develop materials, activities and guidance strategies.

**IV. Evaluation**

- 1. The instructor will maintain a continuous record of each student's progress on an institutionally approved grade sheet or computerized substitute. All instructors must keep records in such a way that information would be clear to a second party having to check grade computation in special cases. An explanatory legend should be provided on the grade sheet.
- 2. The evaluation of the assignments should be based on the student's mastery of the assigned objectives. In addition assignments, the instructor may require quizzes and exercises on course content. The instructor may also require a journal or free writing assignments.
- 3. The course projects will be devised at the instructor's discretion.
