**I. Catalog Description**

Presents a newsgathering approach to photography. Stresses the principles and mechanics of photography in the mass media. **Prerequisite: INRW 0311 or ESOL 0340 (can be taken concurrently) or by placement exam or ENGL 1301 with a “C” or better or ENGL 1302 with a “C” or better. (2:2) Lab fee.**

**II. Course Objectives**

Upon satisfactory completion of this course, students will be able to:

- A. Unit I. Elements of Visual Communication
  - 1. Understand basic elements of shapes and colors.
  - 2. Analyze print advertisements.
  - 3. Recognize and discuss the social aspects of the visual.
  
- B. Unit II. Photography
  - 1. Identify genres in photography.
  - 2. Define the technical aspects of the photograph.
  - 3. Recognize and define cameras, lenses and accessories.
  - 4. Understand and describe the differences between digital and photochemical photography.
  
- C. Unit III. Composition and Lighting
  - 1. Define elements of composition.
  - 2. Control details of composition.
  - 3. Apply principles of basic lighting.
  
- D. Unit IV. Photojournalism
  - 1. Cover a news event and bring back usable photos.
  - 2. Use a camera as a reporting tool.
  - 3. Edit digital photos on computer platform.

### III. Evaluation

Portfolio: Students will maintain a minimum of 12 news photos that meet minimum standards for newspaper publication.

A. Pre-assessment

On the first day of class the instructor may give students a preliminary quiz on their basic photographic and camera knowledge. Students failing to demonstrate minimum familiarity with basic workings of a camera may be asked to schedule extra lab time to develop their skills.

B. Unit Assignments

1. Unit assignments are designed to give the student the hands-on practice needed to become competent with cameras and photo newsgathering techniques. Each photo assignment will be geared toward possible use in an issue of the student newspaper, - *Tejano Tribune*.
2. Assignments are due at the appointed deadline. It is the student's responsibility to complete assignments as outlined in this syllabus.
