**I. Catalog Description**

Provides an introduction to the field of communication. Surveys the theories and issues associated with the communication process from intrapersonal communication to mass communication. **(3:0)**.

**II. Course Objectives**

Upon satisfactory completion of this course, the student will be able to:

- A. Identify basic communication processes that apply to all settings.
- B. Effectively participate in experiences using techniques of active learning, conflict resolution, information gathering, and team presentations.
- C. Evaluate and analyze how communication is cultural, social, and political. (e.g., race, gender, class, religion, etc.)
- D. Implement effective communication strategies within personal relationships, small groups, and organizations.
- E. Address the ethical and moral issues within a multicultural, democratic, and technologically complex society.
- F. Practice reading and writing about scholarly research methods.
- G. Develop fundamental media literacy skills.
- H. Distinguish among the different careers available in the field.

**III. Evaluation**

Students will participate in a variety of learning activities that will track their progress toward meeting course objectives. This includes, but is not limited to, in-class assignments, writing journals, quizzes,

exams, team building projects, and individual/small group presentations. Depending on the course instructor, all of these activities or only a selection may be used.
