I. Catalog Description

Prepares students to take the Texas Certified Shorthand Reporter and the Registered Professional Reporter examinations through the use of mock examinations. To exit this course, students must write on a stenographic machine and pass at a minimum speed of 225 Q&A material with 95% accuracy on two mock examinations and pass two 5-minute timed writings at 180 wpm with 97% accuracy on literary material, pass two 5-minute timed writings at 200 wpm with 97% accuracy on jury charge material and pass two 5-minute timed writings at 225 wpm with 97% accuracy on Q&A material. This course is designed to be repeated. **Prerequisite: CRTR 2435. (3.1). Lab fee.**

II. Course Objectives

Upon satisfactory completion of this course, the student will be able to:

- A. Write at a minimum speed of 180 words per minute and transcribe with 97% accuracy, two 5-minute literary timed writings.
- B. Write at a minimum speed of 200 words per minute and transcribe with 97% accuracy, two 5-minute jury charge material timed writings.
- C. Write at a minimum speed of 225 words per minute and transcribe with 97% accuracy, two 5-minute Q&A timed writings.
- D. Transcribe with 95% accuracy two mock certification exams.
- E. Show good proofreading skills and oral presentation techniques through read back of notes with clarity, good diction, and proper punctuation and practice finger drills.

Pass simulated CSR and RPR examinations and/or written knowledge tests.
