I. Catalog Description

Studies dental hygiene care for the medically or dentally compromised patient including supplemental instrumentation techniques. A grade of "C" or better is required in this course to take the next course.
Prerequisites: DHYG 1103 and DHYG 1201 and DHYG 1219 and DHYG 1239 and DHYG 1304 and DHYG 1431. Corequisites: BIOL 2420 or BIOL 2421 and DHYG 1211 and DHYG 1235 and DHYG 1261. (2:1). Lab fee.

IV. Evaluation

1. *Pre-assessment*

There will be no pre-assessment.

2. *Grading Requirements*

- To successfully complete this course, students must earn an overall grade of 75% or better in the course.
- Students who DO NOT complete all listed tasks will receive an F for the course.
- No retake examinations will be given
- Assignments on prepU or other similarly approved sources not turned in on due date and time will be graded on a scale of 0 – 75.

3. *Evaluation Methods and Overall Course Weights*

- Four (4) Chapter Examinations: 40%
- Final Exam: 5%
A five-page research paper on treatment requirements for the special needs population, graded according to the Mini Research Paper Rubric.
- PrepU Weekly Assignments: 55%
Students will complete PrepU chapters selected from Wilkin's book, *Clinical Practice of the Dental Hygienist*, from the Special Patients Section and the chapters on Fluoride and Smoking Cessation. Student must reach a mastery level of 3 on prepU.
 - Mastery Level 3 Grade 93%.
 - Any two levels above a 3 95%
 - Any level 6 or above 98%
