### I. Catalog Description

Develops basic skills and techniques of acting including increased sensory awareness, ensemble performing, character analysis, and script analysis. Emphasizes the mechanics of voice, body, emotion, and analysis as tools for the actor. Discusses playwriting terminology, styles, plot and dialogue development. Scene and Act development, and dramatic action as a driving force of a play. Provides a main focus on the playwright as storyteller and intellectual artist, while developing skills in practical word craft for the stage. Utilizes the writing of several scenes of varying lengths and the reading/critiquing of those scenes in class. Course culminates with a barebones script-in-hand presentation of final scenes. (3:0).

# II. Course Objectives

- A. Unit I. Playwriting Basics/Understanding the Creation of Dynamic Characters
  - 1. Utilize various tools to develop and organize inspiration for characters.
  - 2. Develop a character using the motif of "intentions and obstacles."
  - 3. Create characters with depth and individuality.
  - 4. Write a 2-5 page scene utilizing character development.
  - 5. Accept and give meaningful, constructive criticism.
- B. Unit II. Plotting the Play/Creating Dramatic Action
  - 1. Define and create plot through techniques of central theme and conflict/resolution.
  - 2. Create a dramatic arc and dramatic action through conflict of characters.
  - 3 Identify and utilize linear action as opposed to episodic action.
  - Write a scene toward a known conclusion as opposed to an unknown ending.
  - Write a 5-10 page scene exemplifying plot in its various forms.
- C. Unit III. Individuation of Character as He/ She Relates to Plot
  - 1. Create characters with distinct voice, which underlines character identifiers.

- 2. Use the monologue as a tool of internal character development.
- 3. Develop beginning skills which allow the characters to grow organically out of a plot.
- 4. Tell a story through the characters rather than about them.
- 5. Write a 10-20 page scene utilizing 3-5 characters.

#### D. Unit IV. Synthesizing Plot and Characters into a Harmonious Whole

- 1. Develop rewriting skills based on observations made in rehearsal.
- 2. Use in class critiques as the springboard for identifying options for dramatic development.
- 3. Listen intelligently to the verbal and unspoken suggestions of actors and production assistants.
- 4. Use rehearsals to identify problems and change the script
- 5. Realize the ongoing and unending process of play development through rewrites and in rehearsal work

#### III. Evaluation

Students will be write three separate scenes of varying length and complexity. In addition, students will serve as mentors to another writer in the class and will assist in the writing, critique, and rewriting process. A playwright critique comparing the works of two published authors will be assigned. A playwright's review of three different EPCC productions will be written.
