  - 3. Basic concepts for offensive and defensive strategy
  
- B. Unit II
  - 1. Dribbling
  - 2. Ball handling-passing and receiving the ball
  - 3. Shooting
  - 4. Protecting and controlling ball
  
- C. Unit III
  - 1. Defensive stance (sliding, hopping, etc.)
  - 2. Boxing out
  - 3. Zone and man to man defense
  - 4. Guarding offensive players
  
- D. Unit IV
  - 1. Game related situations
  - 2. Small sided games
  - 3. Half court games
  - 4. Full court scrimmages
  - 5. Class tournament

### **III. Evaluation**

- A. Mid term examination-Students will be administered test over basketball terminology, rules and regulations and offensive and defensive strategies.
- B. Pre and Post Testing on Basketball Basic Skills- to include dribbling, passing shooting.
- C. Final Examination- Written Examination Comprehensive covering the game of basketball.
- D. General evaluation options available for use by all instructors includes: Multiple Choice objective exams, short answer essay exams, True/False objective exams, classroom presentation, attendance or any combination of these options.
