I. Catalog Description

Presents fundamental concepts of bankruptcy law and procedure including individual and business liquidation and reorganization with emphasis on the paralegal's role. (3:0).

II. Course Objectives

Upon satisfactory completion of this course, the student will be able to:

- A. Define and use the terminology related to bankruptcy law.
- B. Explain the origins and development of bankruptcy law.
- C. Locate the statutory and Constitutional provisions that govern bankruptcy.
- D. Distinguish the roles and definitions of the various parties to the bankruptcy process (debtors, creditors, trustees, courts, and attorneys) and identify debtor and creditor rights.
- E. Identify and explain the distinctions among the various forms of bankruptcy along with the peculiarities, advantages, and disadvantages of each form.
- F. Prepare the essential documents related to the filing of a proceeding in bankruptcy.
- G. Describe the role and ethical considerations of the paralegal in bankruptcy law.
- H. Discuss the specific "billable" tasks associated with bankruptcy law.
