## I. Catalog Description

Provides a health-related work-based learning experience that enables the student to apply specialized occupational theory, skills, and concepts. Direct supervision is provided by the clinical professional. A grade of "C" or better is required in this course to take the next course. (0:18). Professional Practice Insurance required.

## II. Course Objectives

## Units 1-6

Upon satisfactory completion of these, the student will be able to transcribe reports from different medical specialties.

For each unit, the student will download and transcribe 25 reports. the transcribed reports will be submitted for comparison. A notebook for vocabulary and spelling will be maintained.

#### Unit 7

Upon satisfactory completion of this unit, the student will be able to:

- 1. "Clean up" dictation so that the resulting report is grammatically correct.
- 2. Proofread and edit entire documents for misspellings, run-on or fragmented sentences, punctuation errors, or misused words.
- 3. Compare and contrast different medical transcription work environments, to include:
  - a. Hospitals and specific hospital departments (including non-acute care facilities)
  - b. Clinics
