### I. Catalog Description

Develops musical skills through the study and performance of a wide variety of ensemble literature from the sixteenth through the twentieth century. Open to all string, woodwind, brass, percussion, and piano students. (0:3).

### II. Course Objectives

Upon satisfactory completion of this course the student will be able to:

- A. Participate in public performances of popular, classical and contemporary chamber music.
- B. Play percussion ensemble literature in various styles as indicated by the music selected.
- C. Apply the principles and techniques of professional percussion ensembles.
- D. Demonstrate principles of stage projection and performance behavior appropriate to percussion ensembles.

### III. Evaluation

Course evaluation is based on subjective appraisal by the instructor of:

- A. Attendance and cooperation are required in ALL performances and rehearsals.
- B. Application of principles of ensemble performance: intonation, rhythmic accuracy and interpretation.
- C. Application of the above principles  
Attendance. The final grade will be determined as follows:
  - 1. If a student misses a performance their final grade will be lowered by two letter grades.
  - 2. The student's grade will go down by a letter grade for every unexcused absence from a rehearsal starting with the third absence. After six unexcused absences, the student's grade will result in an F.
  - 3. Tardiness can result in the lowering of the daily grade and will be left up to the discretion of the instructor.
- D. Since there are no written assignments or formal tests in percussion ensemble, a policy on makeup of work is not applicable.
