I. Catalog Description

Introduces the basic elements of music theory, including scales, intervals, keys, triads, elementary ear training, notation, meter, and rhythm. This course does not apply to a music major degree. (3:0).

II. Course Objectives

Upon satisfactory completion of this course the student will be able to:

- A. Recognize and utilize the basic components of music: notation, rhythm, melody, harmony, major and minor scales, chords and key signatures.
- B. Learn the piano keyboard to translate written notes into aural pitches.
- C. Write and identify intervals, the chromatic scale, the whole tone scale, major and minor scales, major and minor chords, diminished and augmented chords, and seventh chords and their inversions.
- D. Analyze chords with roman numerals and jazz symbols.

III. Evaluation

- A. A mid-term and a final will be given for this course. A minimum of 2 extra tests will also be given throughout the semester. Assignments will be given on a regular basis to consistently assess the students' progress.
- B. Scores on the tests and the final exam will be averaged to find the percent score for the course. Percent scores will be converted to letter grades according to the following scale:
 - $\begin{array}{l} 90 \text{ to } 100 = \text{A} \\ 80 \text{ to } 89 &= \text{B} \\ 70 \text{ to } 79 &= \text{C} \\ 60 \text{ to } 69 &= \text{D} \\ \text{below } 60 = \text{F} \end{array}$
