### I. Catalog Description

Reviews music fundamentals, first, second, third, and fourth species two-part counterpoint, dominant seventh chords, chorale harmonization, and four-part diatonic chorale writing. Open to all. **Please contact the Music Coordinator for more information. Corequisite: MUSI 1116. (3:0)**

### II. Course Objectives

Upon satisfactory completion of this course the student will be able to:

- A. Identify and spell all major and minor key signatures contained in the circle of fifths.
- B. Identify and spell all diatonic scales (major, natural minor, harmonic minor, and melodic minor) contained in the circle of fifths.
- C. Identify and spell all chromatic intervals.
- D. Identify and spell all forms of triads, seventh chords, and their inversions.
- E. Compose upper and lower counterpoint melodies against a cantus firmus melody in the practice of 16<sup>th</sup> century modal counterpoint. First, second, third, fourth, and fifth species counterpoint practices will be reviewed.
- F. Identify the guidelines concerning, and compose in the style of, diatonic four-part chorale writing.

### III. Evaluation

- A. Examinations, quizzes, and homework assignments, as well as a comprehensive final examination will be given throughout the semester.
- B. Scores on the tests and the final exam will be averaged to find the percent score for the course. Percent scores will be converted to letter grades according to the following scale:

90 to 100	=A
80 to 89	=B
70 to 79	=C
60 to 69	=D
below 60	=F
