### I. Catalog Description

Develops skills in computer keyboarding techniques. Emphasizes the development of acceptable speed and accuracy levels and formatting basic documents. To exit this course, student must keyboard a minimum speed of 25 wpm by touch with 5 or less errors on at least three 5-minute timed writings. Proficiency exam available. **(3:1)**.

### II. Course Objectives

- A. Unit 1. Introduction
  - 1. Identify and use the basic parts of the computer.
  - 2. Identify the names and functions of the different parts of a window.
  - 3. Use the mouse appropriately.
  - 4. Use the *Start* button.
  - 5. Use the *File Management* system.
  - 6. Access and exit the designated software program.
- B. Unit 2. Technique
  - 1. Develop proper posture.
  - 2. Develop keystroking, spacing, and shifting techniques.
- C. Unit 3. Developing Keyboarding Skill (*Keyboarding Course Lessons 1-25* text and *Keyboarding Pro* program)
  - 1. Keyboard alphabetic copy by touch using proper technique (**Alphabetic Keys, Lessons 1-13**).
  - 2. Keyboard symbols and numeric copy by touch using proper technique (**Figure and Symbol Keys, Lessons 14-25**).
  - 3. Keyboard drills for data entry practice (**Lesson A, Numeric Keypad**).
  - 4. Use basic word processing competencies (**Lesson B, Word Processing**).
    - a. Create, proofread, edit, and print a block style letter.
    - b. Create, proofread, edit, and print a one-page report with a title page.
- D. Unit 4. Skillbuilding (*Championship Keyboarding Drills* text and program)
  - 1. Increase speed through exercises designed to facilitate the development of this aspect of keyboarding skill.
  - 2. Reduce errors through exercises designed to facilitate the development of this aspect of keyboarding.

- E. Unit 5. Timed Writings
  - 1. Keyboard alphabetic text by touch on five-minute timed writings.
  - 2. Minimum requirement: 25 words per minute with five or fewer errors.

### III. THECB Learning Outcomes (WECM)

- 1. Demonstrate keyboarding techniques.
- 2. Apply proofreading and editing skills.
- 3. Create basic business documents.

### IV. Evaluation

- a. Articulated Credit: This course articulates with Ysleta Independent School District and David L. Carrasco Job Corps Center. If you earned a minimum of 85 percent in your high school Business Information Management I class (Ysleta ISD) or in your Finance and Business Office Administration class (David L. Carrasco Job Corps Center) and graduated within the last 28 months, you may be able to get credit for this course. Students complete a ***Request for Award of Non-traditional Credit*** form available on the EPCC website and submit it to the Office of Admissions and Registration. The request forms may be initiated at any EPCC counseling office. The administrative assistants will forward the form to the Evaluations Department at Valle Verde.
- b. Challenge Exam: The Challenge Exam consists of a total of six (6) 5-minute timed writings using *Championship Keyboarding Drills* software. To pass the exam, you must keyboard a minimum of 25 words per minute and with no more than five (5) errors on at least three (3) timed writings. See the Computer Office Lab for details.
