I. Catalog Description

Studies the basic aspect of growth and development throughout the life span. Focuses on growth and development of the individual's body, mind, and personality as influenced by the environment. A grade of "C" or better is required in this course to take the next course. (1:0).

II. Course Objectives

Upon satisfactory completion of this course, the student will be able to:

- A. Describe theories relevant to development such as Freud's Psychosexual Development, Erikson's Psychosocial Development and Piaget's Cognitive Development.
- B. Describe the changes experienced physically during one's lifetime, beginning with conception and ending in death.
- C. Evaluate certain crises which are normative for certain stages of life and the effect they have on development.
- D. Describe the seasons of life, including death and dying.

III. Student Learning Outcomes (SLO's): VOCATIONAL NURSING

Collaborate and co-ordinate with patients, their families and the interdisciplinary/multidisciplinary health care team to implement best practices and to address health promotion and disease prevention, health maintenance and health restoration based on the individual's perception of their health needs.
