**I. Catalog Description**

A studio art course that introduces the materials, processes, and issues pertaining to the making of three-dimensional objects and environments. The course explores the use of varied materials and techniques along with the formal and conceptual principles that form the basis of contemporary sculpture. Focuses on studio production, safety, and aesthetic criticism. **(2:4). Lab fee.**

**II. Course Objectives**

Upon satisfactory completion of the course, the student will be able to:

- A. Visually present and expressively communicate understanding of volumetric form.
- B. Execute concepts of abstraction in the assigned three-dimensional projects.
- C. Exhibit skills in utilizing assigned materials necessary in three dimensional compositions adequate for exhibition.

Upon successful completion of this course, students will:

- 1. Generate works that demonstrate descriptive, expressive, and conceptual approaches.
- 2. Apply the elements of art and principles of design.
- 3. Use varied materials, including, but not limited to, clay, metal, plaster, wood, and found objects.
- 4. Demonstrate additive and subtractive processes.
- 5. Analyze and critique works verbally and/or in writing.
- 6. Relate sculpture to art history and contemporary artistic production.
- 7. Demonstrate an appropriate level of professional practice, including safety, craft, and presentation.
