I. Catalog Description

A studio art course that furthers the study of the technical and conceptual basics of photography as a creative medium. **Prerequisite: ARTS 2356. (2:4). Lab fee.**

II. Course Objectives

Upon satisfactory completion of the course, the student will be able to:

- A. Unit I. Camera Calibration
 1. Calibrate a camera
 2. Adjust the development of negatives to coincide with the camera's calibration.
- B. Unit II. The "Zone System" and Pre-visualization
 - 1. Use the Zone System when exposing negatives
 - 2. Compose a photograph by the use of pre-visualization.
 - 3. Create a full-scale print.
- C. Unit III. Processing Negatives and Prints.
 - 1. Adjust negative development for specific situations.
 - 2. Discuss the archival print process.
 - 3. Identify and discuss the principles of sensitometry.
- D. Unit IV. The History of Photography
 - 1. Discuss the development of photography.
 - 2. Identify the contributions of individuals to the development of photography.
 - 3. Identify photographic processes used in various historical periods.
- E. Unit V. Lighting Techniques.
 - 1. Identify lighting techniques and use them to create a desired effect.
 - 2. Discuss lighting techniques used in the studio.
- F. Unit VI. Portfolio Development.
 - 1. Present his/her work in a professional manner.
 - 2. Create a portfolio that reflects an advanced knowledge of technique.

III. THECB Learning Outcomes (ACGM)

Upon successful completion of this course, students will:

- 1. Demonstrate the techniques of wet and/or dry photographic processes.
- 2. Apply the elements of art and principles of design to photographic works.
- 3. Analyze and critique printed photographic works verbally and/or in writing.
- 4. Employ discipline-specific vocabulary in the evaluation of traditional and contemporary photography.
- 5. Relate photographs to historical and contemporary developments in the field.
- 6. Demonstrate an appropriate level of professional practice, including safety, craft, and presentation.
