**I. Catalog Description**

An instructional program designed to integrate on-campus study with practical hands-on work experience. In conjunction with class seminars, the individual student will set specific goals and objectives in the study of communication. Students interested in pre-professional experience should enroll in this course. **Students must secure an internship prior to the first day of class. **II. Objectives**

Upon satisfactory completion of this course, students will be able to:

- A. Develop the job skills that will lead to an entry-level position in the media.
- B. Compose a satisfactory resume.
- C. Respond effectively in a job interview.
- D. Participate as an effective member of the work site team.

**III. Evaluation**

The student is required to complete 240 internship hours in the practicum course. Two hundred and twenty-five hours will be earned at the work site and fifteen are derived from participation in the weekly one hour seminar. The internships are completed at electronic media outlets, including radio and television stations, production companies, and advertising agencies. During the semester, the student will spend a minimum of fifteen hours a week at the internship site.
