**I. Catalog Description**

This course is an examination of the principles of movement generation, phrasing, choreographic structure, and manipulation. Integration of choreographic principles will foster the growth of personal artistic style. **Prerequisite: DANC 1201. (3:1).**

**II. Course Objectives**

Students will learn foundation jazz dance techniques by understanding foundational jazz movements and comprehending historical information. At the end of the course, the student will learn the following content:

- A. **Unit I- Dance Composition Forms**
1. Comprehend Subjective, Objective and Interpretation Responses.
  2. Analyze and Explore Choreography Investigation #1: ABA and Rondo.
  3. Analyze and Explore Choreography Investigation #2: Theme/Variation and Repetition.
  4. Analyze and Explore Choreography Investigation # 3: Time and Rhythm.
  5. Analyze and Explore Choreography Investigation # 4: Prop Investigation.
- B. **Unit II- Dance Composition with Laban Movement Analysis**
1. Analyze and Explore Choreography Investigation #1: Body and Effort.
  2. Analyze and Explore Choreography Investigation #2: Effort Drives and Shapes.
  3. Analyze and Explore Choreography Investigation #3: Space and Relationships.
- C. **Unit III – Dance for Film**
1. Comprehend and Explore White Balance/ Exposure/ Focus/Linear versus Non-Linear editing.
  2. Comprehend and Explore Choreography Investigation #1: Framing- Close-Up, Mid Shot, Long Shot, Wide Shot and Tight Shot.
  3. Comprehend and Explore Choreography Investigation #2: Framing (Continue)-Over the Shoulder, Bird Eyes View, Worm Eyes View, Arc and Pan.
- D. **Unit IV – Immersive Dance Choreography Group Project**
1. Create a three-week group choreography project around EPCC- Valle Verde Campus Building A.

**III. THECB Learning Outcomes (ACGM)**

Upon successful completion of this course, students will:

1. Demonstrate choreographic principles such as motif, theme and variation, use of space, time, and energy, positive/negative space through creation of solo/group movement studies.
2. Edit, refine, embellish, and amplify movement content.
3. Analyze compositions through verbal and written self and peer assessments.
4. Distinguish the responsibilities of choreographer and dancer in the symbiotic relationship.

**IV. Evaluation**

Rubric evaluations for each objective, except objective one, and a final project rubric evaluation. Unit I (objective one) contains a written evaluation.
