**I. Catalog Description**

An introduction to and familiarization with components and systems related to tractor trailer service. Emphasis on records required by the Department of Transportation. **(2:3). Lab fee.**

**II. Course Objectives**

Upon satisfactory completion of this course, the student will be able to:

- A. Apply proper safety procedure.
- B. Make necessary repairs to the frame and trailer.
- C. Describe the chassis frame of a heavy-duty truck.
- D. List the materials from which frame rails are made and describe the characteristics of each.
- E. Explain the elements of frame construction.
- F. Describe how frame damage can occur due to impact and overloading.
- G. Carry out basic chassis frame alignment checks.
- H. Explain how the chassis frame, side rails, and cross members can be repaired.
- I. List some guidelines to follow when using frame repair hardware.
- J. Explain the various types of hitching mechanisms used and their effects on tractor/trailer or train designation.
- K. Outline some common trailer maintenance practices.

**III. THECB Learning Outcomes (WECM)**

- 1. Inspect vehicles and make necessary repairs to the tractor or trailer to Department of Transportation standard
- 2. Complete Department of Transportation documentation using appropriate forms and procedures.

**IV. Evaluation**
