I. Catalog Description

Discussion of theory and practice with drafting methods and the terminology required to prepare working drawings in specific or various occupational fields. **(3:3). Lab fee.**

II. Course Objectives

Upon satisfactory completion of this course, the student will be able to:

- A. Introduction to Drafting and Print Reading
 1. Identify fundamentals of blueprint reading.
 2. Identify blueprint symbols.
 3. Illustrate the use of lines in a drawing.
 4. Interpret scales.
 5. Interpret title block elements.
 6. Interpret drawings correctly.
 7. Construct a drawing using dimensioning lines.

- B. Shape Description
 1. Identify section views.
 2. Create a multi-view drawing of an object.

- C. Size Description and Annotations
 1. Examine dimensioning mechanics.
 2. Examine tolerancing terms.
 3. Perform GD and T (Geometric dimensioning and tolerancing).

- D. Industrial Drawings
 1. Interpret different types of drawings commonly used in the industrial field such as electrical, electronics, mechanical, welding, plumbing, etc.

- E. Structural Blueprints
 1. Interpret structural blueprints.

- F. Specialized Parts and Prints
 1. Utilize common measurements systems and precision measurement tools.
 2. Create free-hand sketches of a project.

3. Identify the different menu areas of AutoCad and their functions.
4. Modify existing blueprints.

III. THECB Learning Outcomes (WECM)

1. Define the elements of drafting that pertain to specific or various occupational fields.
2. Produce working drawings and sketches relevant to an individual technical discipline.

IV. Evaluation

Students must demonstrate the knowledge and skills stated in the objectives in order to complete the course. Exams, quizzes, and lab assignments will be determined by the instructor.
