## I. Catalog Description

Safety rules and regulations. Includes the selection, inspection, use, and maintenance of common tools for electricians. Emphasis on OSHA and NEC code compliance. (3:1). Lab fee.

## II. Course Objectives

- A. Upon satisfactory completion of this course, the student will be able to
  - 1. Comply with Occupational Safety and Health Administration Standards (OSHA).
  - 2. Obtain OSHA 30 Construction certification.
  - 3. Utilize Personal Protective Equipment (PPE) appropriately.
  - 4. Introduction to the National Fire Protection Association (NFPA) 70E.
  - 5. Comply with safety precautions (e.g. call before you dig).
  - 6. Recognize safety hazards, practice eye and hearing safety.
  - 7. Utilize safe procedures when using step and extension ladders on the job site.
  - 8. Safely operate and maintain the hand and power tools common to electrical work.
  - 9. Introduction to electrical metering equipment (e.g. multimeter, polarity tester).
  - 10. Navigate the National Electrical Code (NEC), definitions and trade terminology.
  - 11. Introduction to Ohm's Law.
  - 12. Apply grounding principles.
  - 13. Identify Service conductors, Feeders and Branch circuits.
  - 14. Distinguish conductors with color coding.
  - 15. Treat others with respect and display effective customer service.
  - 16. Follow organizational rules and regulations, practice safety awareness.
  - 17. Demonstrate the self-confidence to ask questions, identify work limitations.
  - 18. Practice personal time management, document on the job training hours and duties.
  - 19. Maintain a safe and clean jobsite.
  - 20. Introduction to CPR and First Aid procedures.
  - 21. Locate Safety Data Sheet (SDS).
  - 22. Practice safety awareness with heavy machinery and equipment.

## **III.** THECB Learning Outcomes (WECM)

- 1. Explain electrical hazards and how to avoid them in the workplace.
- 2. Discuss safety issues concerning lockout/tagout procedures.
- 3. Demonstrate safe work habits using common hand and power tools for electricians.

The knowledge and skills stated in the objectives must be demonstrated by the students in the form of tests and assignments in order to complete the course. Letter grades will be determined as follows:
