I. Catalog Description

A health-related work-based learning experience that enables the student to apply specialized occupational theory, skills, and concepts. Direct supervision is provided by the clinical professional. A grade of "C" or better is required in this course to take the next course and/or for this course to be eligible for "course completion" credit or eligibility to take licensing exam. **(0:3). Professional Practice Insurance required.**

II. Course Objectives

Upon satisfactory completion of this course, the student will be able to:

- A. Demonstrate professional practice in patient care within the legal, moral, and ethical roles and responsibilities of an Emergency Medical Technician- Paramedic.
 - 1. Attend and participate in clinical rotations as assigned.
 - 2. Observe clinical dress code and professional behavior.
 - 3. Display initiative and interest.
 - 4. Exhibit responsibility in work assigned.
 - 5. Accept constructive evaluation/feedback.
 - 6. Maintain a positive attitude.
 - 7. Demonstrate ability to participate as a member of a team to provide patient care.
 - 8. Adhere to rules and regulations.
 - 9. Adhere to safety practices.

B. Evaluate and identify the patient's existing conditions and provide the most effective forms of treatment in an appropriate prioritized and timely manner.

- 1. Perform patient assessments demonstrating:
 - a. Use of appropriate principles and techniques in obtaining medical history.
 - b. Perform comprehensive physical examinations.
 - c. Explain the pathophysiology of the physical findings.
 - d. Apply appropriate critical thinking skills for treatment based on physical exam and patient history.

2. Prioritize, organize, and provide appropriate treatment based on findings. Emphasis is to be placed on patients with the following categories:

- a. Medical
- b. Trauma
- c. Neurologic
- d. Burns
- e. Obstetric and Gynecologic
- f. Neonatal and Pediatric
- g. Sepsis & Multisystem Organ Dysfunction Syndrome
- h. Cardiac
- 3. Demonstrate appropriate technique and understanding for the following equipment/results:
 - a. Perform blood draw and evaluation of results for ABG, blood sample, urine, and electrolytes
 - b. Demonstrate appropriate Set up and operation of Mechanical Ventilator
 - c. Perform Advanced Airway Management Procedures (Orotracheal Intubation, Nasotracheal Intubation, Digital Intubation, Retrograde Intubation, Superaglottic airway insertion, Needle Cricothyrotomy, Surgical Cricothyrotomy)
 - d. Demonstrate appropriate set up and operation of Intra-aortic Balloon pump
 - e. Demonstrate appropriate set up and operation of Hemodynamic Monitoring (Central Line, Arterial Line)
 - f. Perform IV catharization with administration of appropriate fluids and/or medication administration.
- 4. Observe, assist with, and participate as a team member in the following situations:
 - a. Cardiac arrest management
 - b. Respiratory arrest management
 - c. Multiple Casualty Incidents
 - d. Hazardous Material Incidents
- 5. Demonstrate the knowledge and principles for Ground transport of a critical patient.
- 6. Demonstrate the knowledge and principles for Flight transport of a critical patient

III. THECB Learning Outcomes (WECM)

As outlined in the learning plan, apply the theory, concepts, and skills involving specialized materials, tools, equipment, procedures, regulations, laws, and interactions within and among political, economic, environmental, social, and legal systems associated with the occupation and the business/industry; and will demonstrate legal and ethical behavior, safety practices, interpersonal and teamwork skills, and appropriate written and verbal communication skills using the terminology of the occupation and the business/industry.
