I. Catalog Description

Management of the interaction among facility, people, equipment, operation, service, and maintenance. Includes building structure and interior elements, air conditioning, furniture, grounds, and waste management. (3:3). Lab fee.

II. Course Objectives

Upon satisfactory completion of this course, the student will be able to:

- A. Navigate the National Electrical Code (NEC).
- B. Implement proper code grounding and bonding using NEC tables.
- C. Size conductors using NEC tables.
- D. Perform Conduit Bending.
- E. Install different wiring methods.
- F. Perform box fill calculations.
- G. Inspect and detect electrical/mechanical deficiencies using the NEC.
- H. Develop electrical preventive maintenance plans.
- I. Interpret blueprints for circuit installation or modification.
- J. Introduction on the installation, description of Solar Panel systems and wind-generated systems.
- K. Demonstrate basic carpentry skills.
- L. Introduction to Automation Technology.

III. THECB Learning Outcomes (WECM)

- 1. Identify building mechanical systems and related technologies.
- 2. Design a facility maintenance program.
- 3. Develop an inventory management plan.
- 4. Develop a security plan.
- 5. Assess the effectiveness of the facility maintenance program.
