### I. Catalog Description

Survey of the evolution of fashion change, traced through garment development from ancient times to present day. A study of customs and silhouettes of each historical period and their modern day adaptations. Emphasizes the roles that technology, politics, economics, art, and sociology play in fashion's continual change. (3:0).

### II. Course Objectives

- A. Unit I. Fashion Theory
1. Define fashion as the acceptance of any style by a large number of people at any given time.
  2. Analyze the distinction between clothing and fashion.
  3. Describe how and why clothing and body adornment began and continues.
- B. Unit II. Dominant Influences in Fashion Development and Change
1. List and delineate the great influences in the constantly changing world of fashion.
  2. Discuss the influence of political, economic, technological, aesthetic, cultural, and sociological patterns on the fashion trends of various periods in history.
  3. Discuss the role that women have played in the design and production of everyday clothing and fashion items.
  4. Deliberate the socialization of sex-roles through the use of fashion items through various periods in history.
  5. Discuss the democratization of clothing.
- C. Unit III. Historical Analysis of Fashion through the Ages
1. Classify important styles from various periods of fashion from the ancient past to the present.
  2. List and delineate the great designers who have influenced the world of fashion.
  3. Identify important historical events that have influenced the different period fashions.
  4. Identify important people who have influenced the different period fashions.
  5. Identify important art movements that have influenced the different period fashions.
- D. Unit IV. Historical and Contemporary Research
1. Use trade publications, libraries and internet to research fashion history information.
  2. Identify garment attributes.
  3. Define well-known apparel types by name.

4. Discuss the evaluation and interpretation of current economic and fashion trends.
5. Read and interpret technical and trade periodicals.
6. Write memos, letters, and abstracts.
7. Listen actively, ask clarifying questions, and express ideas verbally.

1. Identify significant historic fashions from early civilizations to the twentieth century.
2. Describe social influences which have historically affected fashion.
3. Explain values communicated through clothing in specific historical periods.
