I. Catalog Description

A survey of the social, political, economic, cultural, and intellectual history of the United States from the Civil War/Reconstruction era to the present. United States History II examines industrialization, immigration, world wars, the Great Depression, Cold War and post-Cold War eras. Themes that may be addressed in United States History II include: American culture, religion, civil and human rights, technological change, economic change, immigration and migration, urbanization and suburbanization, the expansion of the federal government, and the study of U.S. foreign policy. **Prerequisite: Placement at College Level Reading or Writing by TSIA or equivalent; OR completion of INRW 0311 or INRW 0312 or ESOL 0340 with a “C” or better. (3:0).**

II. Course Objectives

Upon satisfactory completion of this course, the student will be able to:

A. Unit One: Politics, 1877-1900

1. Discuss American domestic and foreign policies from post-Reconstruction to end of the century.
2. Analyze the social, political, and economic implications of the westward movement of the United States from post-Civil War to end of the century.
3. Examine federal Indian policy from military, political, and diplomatic perspectives including the government forced assimilation programs.

B. Unit Two – Evolution of the Industrial United States, 1870-1900

1. Explain how the rise of corporations, heavy industry, and mechanized farming transformed the American people.
2. Analyze the massive immigration after 1870 and how new social patterns, conflicts, political philosophy and ideas of national unity developed amid growing cultural diversity.
3. Discuss the rise of the American labor movement and how political issues reflected social and economic changes.
4. Discuss the rise of the American farm movement (Populism) and how political issues reflected social and economic changes.
5. Examine federal Indian policy and United States foreign policy after the Civil War.

C. Unit Three – The Emergence of Modern America, 1900-1930

1. Analyze the rise of the Progressive movement and how it addressed problems of industrial capitalism, urbanization, democracy, political corruption, and immigration.
2. Describe the changing role of the United States in world affairs through World War I.
3. Explain how the nation changed from the end of World War I to the eve of the Great Depression.
4. Describe the emergence of social movements including women, prohibition, religion, and organized labor.

D. Unit Four —The Great Depression and World War II, 1929-1945

1. Explain the causes and consequences of the Great Depression in American society.
2. Discuss how the New Deal addressed the Great Depression, transformed American federalism, and initiated the welfare state.
3. Describe the exclusion and inclusion of minority groups during this period.
4. Analyze the causes and course of World War II, the character of the war at home and abroad, and its reshaping of the U.S. role in world affairs.

E. Unit Five – The United States in the Post-World War II Era, 1945 to early 1970s

1. Examine the economic boom and social transformation of postwar United States.
2. Describe and analyze how the Cold War and conflicts in Korea and Vietnam influenced domestic and international politics.
3. Discuss the struggle for social equality, various reforms [such as environmentalism] and the extension of civil liberties.

F. Unit Six – Contemporary United States, 1968 to the Present

1. Explain recent developments in foreign and domestic politics.
2. Discuss economic, social, and cultural developments in contemporary United States.
3. Describe and analyze the rise of the New Left and New Right political movements.

D. PREASSESSMENT

Due to the nature of history there is no challenge exam for the course. A reading test can be given in HIST 1302 to determine preparedness of students. Individual instructors may use a unit preassessment at their own discretion. Note will be made of this in their personal syllabi.
