I. Catalog Description

Career-related activities encountered in the student's area of specialization offered through an individualized agreement among the college, employer, and student. Under the supervision of the college and the employer, the student combines classroom learning with work experience. Includes a lecture component. (1:9).

II. Course Objectives

Upon satisfactory completion of this course, the student will be able to:

A. Safety

- 1. Work in a safe and productive manufacturing workplace.
- 2. Perform safety and environmental assessments.
- 3. Identity unsafe conditions and take corrective action.
- 4. Participate in safety training and equipment safety training.
- 5. Utilize effective, safety-enhancing workplace practices.
- B. Manufacturing Processes and Production
 - 1. Identify customer needs.
 - 2. Determine resources available for the production process.
 - 3. Set up and verify equipment for the production process.
 - 4. Set team production goals.
 - 5. Make job assignments.
 - 6. Coordinate work flow with team members and other work groups.
 - 7. Communicate production and material requirements and product specifications.
 - 8. Perform, monitor and document the process to make the product.
 - 9. Document product and process compliance with customer requirements.
 - 10. Prepare final product for shipping or distribution.
- C. Maintenance Awareness
 - 1. Perform preventive maintenance and routine repair.
 - 2. Recognize potential maintenance issues with basic production system, including knowledge of

when to inform maintenance personnel of problems with the different systems such as electrical, hydraulics, pneumatics, automation, etc.

- D. Green Production
 - 1. Monitor environmental aspects at each stage of production.
 - 2. Implement continous improvement in environmental assurance practices.
 - 3. Utililize advanced materials in production to reduce weight and increase life.
 - 4. Reprocess materials by recycling and reuse throughout product life cycle to optimize waste reduction.
- E. Quality Practices and Measurements
 - 1. Suggest continous improvements.
 - 2. Inspect materials and product/process at all stages to ensure they meet specifications.
 - 3. Document the results of quality test.
 - 4. Communicate quality issues.
 - 5. Take corrective actions to restore or maintain quality.
