I. Catalog Description

Describes the architecture, components, and basic operation of routers and explains the basic principles of routing and routing protocols. It also provides an in-depth understanding of how switches operate and are implemented in the LAN environment for small and large networks. **Prerequisite: ITCC 1314. (3.1). Lab fee.**

II. Course Objectives (main title)

Upon satisfactory completion of this course, the student will be able to:

- A. Describe and explain basic switching concepts and the operation of Cisco switches.
- B. Describe the purpose, nature, and operations of a router, routing tables, and the route lookup process.
- C. Describe how VLANs create logically separate networks and how routing occurs between them.
- D. Describe dynamic routing protocols, distance vector routing protocols, and link-state routing protocols.
- E. Configure and troubleshoot static routing and default routing (RIP and RIPng).
- F. Configure and troubleshoot an Open Shortest Path First (OSPF) network.
- G. Configure and troubleshoot access control lists (ACLs) for IPv4 and IPv6 networks.
- H. Configure and troubleshoot Dynamic Host Configuration Protocols (DHCP) for IPv4 and IPv6 networks.
- I. Configure and troubleshoot Network Address Translation (NAT) operations.

III. THECB Learning Outcomes (WECM)

1. Configure and maintain routers and switches
2. Resolve common issues with routing protocols, virtual LANs, and inter-VLAN routing in both IPv4 and IPv6 networks.
3. Configure WLANs.
