I. Catalog Description

Presents fundamental concepts of contract law including formation, performance, and enforcement of contracts under the common law and the Uniform Commercial Code as well as a study of deceptive trade practices with emphasis on the paralegal's role in contract law. **(3:0)**.

II. Course Objectives

Upon satisfactory completion of this course, the student will be able to:

- A. Define the terminology related to contract law.
- B. Discuss the relationship among the concepts of law, order, and justice.
- C. Distinguish the law of business from other areas of law and the reasons for studying business law.
- D. Identify the need for and purposes of a legal system.
- E. Identify the sources of law in the American legal system.
- F. Describe the effects of international laws and treaties on the business environment, including the European Community and the North American Free Trade Agreement on Tariffs and Trade.
- G. Apply United States laws in an international environment.
- H. Identify the fundamentals of international business and how to resolve disputes in the international context.
- I. Identify the elements of a contract to include offer and acceptance and consideration.
- J. Interpret the proper form of contracts.
- K. Apply the statute of frauds, the parole evidence rule, and rules of contract integration and interpretation.
- L. Describe third-party beneficiary contracts, assignments and delegation.
- M. Determine the circumstances under which breach of contract occurs and remedies for breach.
- N. Explain the various types of liability for payment of a negotiable instrument and the methods of establishing that liability.
- O. Explain methods of discharging liability for payment of a negotiable instrument.
- P. Explain the method of creation of a security interest and the perfection of that interest.
- Q. Establish the priorities of security interest under Article 9 and exceptions to the rules.
- R. Distinguish among real property, personal property, and fixtures.
- S. Identify the rules of intestate succession, probate and estate administration, and methods of avoiding probate.

- T. Identify the role and ethical considerations of the paralegal relating to contract law.
- U. Draft documents used in contract law.
- V. Discuss the specific “billable” tasks associated with contract law.
