I. Catalog Description

Singing tonal music in various clefs, continued aural study of the elements of music, and dictation of intermediate rhythm, melody and diatonic harmony. **Prerequisite: MUSI 1116. Corequisite: MUSI 1312. (1:1).**

II. Course Objectives

Upon satisfactory completion of this course the student will be able to:

- A. Aurally identify and sing the pitch, “do,” in any diatonic context.
- B. Aurally identify and sing all diatonic pitches using solfege syllables.
- C. Aurally identify, visually identify, and sing all simple chromatic intervals.
- D. Sing major and minor scales (all three versions) ascending and descending, one octave in any given key, using solfege syllables.
- E. Sight-Sing, using solfege syllables or rhythmic syllables (ta, tek, etc.), and simultaneously conduct, various rhythmic exercises.
- F. Sight-Sing, using solfege syllables, and simultaneously conduct, various melodies to include minor melodies.
- G. Accurately notate all elements of a rhythmic line of music (meter, barlines, rhythmic values) onto music staff paper.
- H. Accurately notate all elements of a melodic line of music (meter, barlines, pitch, rhythmic values) onto music staff paper.
- I. Aurally and visually identify, as well as notate on music staff paper: major, minor, augmented, and diminished triads.
- J. Aurally and visually identify, as well as notate on music staff paper: major, dominant, minor, half-diminished, and fully-diminished seventh chords.

III. THECB Learning Outcomes (ACGM)

Upon successful completion of this course, students will:

1. Apply a method of sight singing to diatonic melodies in various clefs, and oral demonstration of simple and compound rhythms.
2. Classify elements of music, such as scales, intervals and chords.
3. Transcribe more complex aural rhythms and diatonic melodies.
4. Transcribe and analyze diatonic harmonic progressions.

5. Read and reproduce rhythms in various simple and compound meters.

IV. Evaluation

- A. Examinations and quizzes will be given to determine the student's progress and understanding of the course material. A minimum of three examinations, a comprehensive final examination, and three quizzes will be administered.
- B. To determine the student's final grade, the instructor will average test and quiz scores. Grades will be based on the following scale:

90 to 100 = A
80 to 89 = B
70 to 79 = C
60 to 69 = D
below 60 = F

- C. Attendance requirements will be specified by instructor and may be a factor in determining the final grade.
