I. Catalog Description

Advanced beginning class instruction in the fundamentals of keyboard technique. Open to all. **Prerequisite: MUSI 1181. (0:3).** Lab fee.

II. Course Objectives

Upon satisfactory completion of this course the student will be able to:

- A. Demonstrate the use of proper fingering, hand position, and control on the keyboard through playing the major scales in two octaves in parallel motion and chords hands together.
- B. Sight read and play moderately easy piano literature, solo, or in ensembles.
- C. Demonstrate an understanding of more extensive music symbols and terminology, more complex rhythm patterns, and basic harmony.

III. THECB Learning Outcomes (ACGM)

Upon successful completion of this course, students will:

- 1. Play additional major and minor scales.
- 2. Introduce select chord progressions and concepts of voice leading.
- 3. Continued harmonization of melodies.
- 4. Perform selected compositions.

IV. Evaluation

- A. The student will be evaluated through piano performance tests of assigned material which shall include playing 12 major scales, chords in root position, first, second, and third inversions, five-finger patterns, and I-IV-V7 chord progressions. The student will also be tested on playing correct rhythms and harmony.
- B. The final exam may include written work over the principles of notation, rhythm, and harmony, and must include the performance of at least one piece selected by the instructor.
- C. Grades from the keyboard performance tests and any daily assignments will be added to the final exam and converted to the following scale:

90 to 100 = A 80 to 90 = B 70 to 80 = C 60 to 70 = D below 60 = F
