I. Catalog Description

Class instruction in fundamental guitar playing, including technique, music-reading, fretboard theory, melodic and harmonic realizations. Open to all. **(0:3)**.

II. Course Objectives

Upon satisfactory completion of this course, the student will be able to:

- A. Describe the physical components of the guitar.
- B. Properly hold the guitar.
- C. Understand how to tune the guitar.
- D. Play the guitar using the correct left-hand technique.
- E. Play the guitar using several right-hand techniques, including fingerstyle and chord strumming.
- F. Read standard music notation for the guitar.
- G. Read tablature notation for guitar.
- H. Understand chord charts and symbols.
- I. Play the natural notes in open position.
- J. Play the chromatic scale in open position.
- K. Play chords.
- L. Understand how to play and count rhythms in different time signatures.
- M. Play exercises and musical compositions presented in the texts and in study sheets given out during class.

III. THECB Learning Outcomes (ACGM)

Upon successful completion of this course, students will:

- 1. Show proper left and right hand technique.
- 2. Demonstrate an understanding of basic music reading in first position.
- 3. Perform basic harmonic chord progressions.

IV. Evaluation

- A. Tests will be given to determine the student's progress and understanding of the course material. A minimum of two written exams and a written final exam covering music reading skills and note recognition will be administered. In addition, students will be given a minimum of three performance tests and a performance final covering musical examples and techniques learned during the semester.
- B. Homework and reading assignments may be given by the instructor to aid the student in learning the course material.
- C. To determine the student's final grade, the instructor will average test scores and assignments. Grades will be based on the following scale:
 - 90 to 100 = A
 - 80 to 89 = B
 - 70 to 79 = C
 - 60 to 69 = D
 - Below 60 = F
- D. Attendance requirements will be specified by the instructor and may be a factor in determining the final grade.
