## I. Catalog Description

Understanding music through the study of cultural periods, major composers, and musical elements, illustrated with audio recordings and live performances. Prerequisite: Placement at College Level Reading or Writing by TSIA or equivalent; OR completion with a "C" or better or concurrent enrollment in the following: INRW 0311 or INRW 0312 or ESOL 0340. (3:0).

# II. Course Objectives

Upon satisfactory completion of this course, the student will be able to:

- A. Utilize **critical thinking skills** to aurally recognize the basic elements of: listening to music (melody, harmony, rhythm, form, and tone color) music terminology, and musical genres and form.
- B. Demonstrate **communication skills** written, oral, and/or visual to describe characteristics of each of the major periods in the history of western art music.
- C. Practice **teamwork skills** when discussing important composers and their works.
- D. Demonstrate **social responsibility skills** when discussing the development of music and its relationship to other arts and historical events.

## **III.** THECB Learning Outcomes (ACGM)

Upon successful completion of this course, students will:

- 1. Identify musical works and elements in a variety of styles.
- 2. Analyze the elements and structures of music using appropriate terminology.
- 3. Critically evaluate the influence of social, political, technological, and/or cultural ideas on music.
- 4. Articulate the significance of music as an art form within historical, cultural and social contexts.

#### IV. Evaluation

A. Examinations will be administered to determine the student's progress and understanding of the course material. A minimum of a midterm and final examination will be administered.

- B. Homework and reading assignments may be given by the instructor to aid the student in learning the course material.
- C. Students will be required to complete at least two concert reports consisting of at least 250 words, during the semester. These concert reports are separate from the Core Assessment Project that will be assigned.
- D. Attendance requirements will be specified by the instructor and may be a factor in determining the final grade.
- E. Core Assessment Group Projects:
  - 1. Students will present research on a piece and discuss the piece in groups. Their research will appear in a slideshow presentation that will be graded on the following criteria:
    - a. Organization of information.
    - b. Clear biography of composer(s)/artist.
    - c. Clear outline of music performed to include: instrumentation, background, anything special or unusual about the performances, likes and dislikes about the music.
    - d. The four following categories graded on a scale of 0 (Poor) to 4 (Excellent):
      - i. Critical Thinking
        - 1. Inquiry—You will be graded on how much IMPORTANT information you included.
        - 2. Analysis—You will be graded on how you break everything down.
        - 3. Creativity/Innovation—Did you present everything in a clear and exciting way?
        - 4. Evaluation—Did you come up with any conclusions based on your research?
      - ii. Communication
        - 1. Content and Development
        - 2. Organization and Structure
        - 3. Grammar and Mechanics
      - iii. Teamwork (Each student will grade their peers)
        - 1. Contribution
        - 2. Cooperation
        - 3. Self-Management
      - iv. Social Responsibility
        - 1. Cultural Worldview Frameworks—Describe the composer's surroundings: his/her country, politics at the time, daily life and important differences in comparison to our lives today.
        - 2. Civic Responsibility—Informing your peers of the information you have found.
        - 3. Understanding One's Role in Regional, National, and Global Communities—Answer why it is important for us on a regional, national, and global level to listen to this music and take a class like this.
- F. To determine the student's final grade, the instructor will average test scores, the Core Assessment Group Projects and any assignments. Grades will be based on the following scale:

90 to 100 = A 80 to 89 = B 70 to 79 = C 60 to 69 = D Below 60 = F
