SUBJECT AREA	MUSIC

I. Catalog Description

The study of analysis and writing of tonal melody and diatonic harmony, including all diatonic chords and seventh chords in root position and inversions, non-chord tones, and functional harmony. Introduction to more complex topics, such as modulation, may occur. Optional correlated study at the keyboard. Open to all. Prerequisite: MUSI 1311 with a "C" or better, or with permission from the Music Program Coordinator. Corequisite: MUSI 1117. (3:0).

II. Course Objectives

Upon satisfactory completion of this course the student will be able to:

- A. Compose diatonic four-part chorale music, following the guidelines and practices of proper voice-leading, vocal-part voicing, contrapuntal principles, treatment of dissonances, and execution of cadences.
- B. Analyze four-part chorale music, identifying chordal harmonies, phrases, motives, diatonic sequences, embellishing tones, and cadences.
- C. Compose four-part chorale music emphasizing secondary dominant and leading tone chords to V, as well as tonicizing scales degrees other than V.
- D. Analyze music literature that introduces chromatic harmony, identifying those areas that initiate modulation, as well as the new tonal areas.

III. THECB Learning Outcomes (ACGM)

Upon successful completion of this course, students will:

- 1. Construct and identify all triads and seventh chords in root position and inversions.
- 2. Properly utilize and identify all non-chord tones.
- 3. Analyze harmonic progressions utilizing standard roman-numeral symbols.
- 4. Compose original harmonic progressions that properly utilize functional harmony.
- 5. Demonstrate on the keyboard musical concepts covered in class, including triads in inversions and progressions with non-chord tones.
- 6. Demonstrate an understanding of rhythmic meter and note duration through score analysis and composition.

IV. Evaluation

- A. Examinations, quizzes, and homework assignments, as well as a comprehensive final examination will be given throughout the semester.
- B. Scores on the tests and the final exam will be averaged to find the percent score for the course. Percent scores will be converted to letter grades according to the following scale:

90 to 100 =A 80 to 90 =B 70 to 80 =C 60 to 70 =D below 60 =F
