I. Catalog Description

Laboratory experiments supporting theoretical principles presented in PHYS 2326 involving the principles of electricity and magnetism, including circuits, electromagnetism, waves, sound, light, and optics; experimental design, data collection and analysis, and preparation of laboratory reports. **Corequisite: PHYS 2326.** (0:3). **Lab fee.**

II. Course Objectives

Upon satisfactory completion of this laboratory course, the student will be able to:

- 1. To experiment, collect data, conclude and report about various electrical, magnetic and optical systems.
- 2. To evaluate accuracy of collected values in comparison to calculated values by calculating percentage errors when learning about electricity, magnetism, optics and light.
- 3. To create new environment systems where to apply various concepts of electricity and magnetism.

III. THECB Learning Outcomes (ACGM)

Upon successful completion of this course, students will:

- 1. Prepare laboratory reports that clearly communicate experimental information in a logical and scientific manner.
- 2. Conduct basic laboratory experiments involving electricity and magnetism.
- 3. Relate physical observations and measurements involving electricity and magnetism to theoretical principles.
- Evaluate the accuracy of physical measurements and the potential sources of error in the measurements.
- 5. Design fundamental experiments involving principles of electricity and magnetism.
- 6. Identify appropriate sources of information for conducting laboratory experiments involving electricity and magnetism.

IV. Evaluation

A. Pre-assessment

There is no pre-assessment for this course.

B. Post-assessment

The scheduling of laboratory exercises will be the sole prerogative of the instructor. This will be indicated to the student in the course syllabus that is distributed at the beginning of the semester. The philosophy of the college endorses frequent evaluation.

C. Remediation

The instructor may provide a student with a means of improving a grade. The timing, form, and method of remediation will be determined by the instructor and included in the course syllabus.

D. Grading

All grading will follow current EPCC Catalog standards. The assignment of letter grades to percent scores obtained in various class activities will be determined by the instructor and included in the course syllabus.
