## I. Catalog Description

Introduction to basic drawing methods and tools. Exploration of techniques available for the design process with emphasis two-dimensional and three-dimensional composition. Course is intended to fulfill all or part of the following National Architectural Accrediting Board (NAAB) Student Performance Criteria: A.1 Professional Communication Skills. (2:4). Lab fee.

## II. Course Objectives

Upon successful completion of this course, students will be able to:

- A. An understanding of the history of techniques associated with representation, visualization, analysis, and presentation in an analog and digital realm.
- B. Implement basic drawing techniques with an understanding of how these skills can be graphically applied to space/form ideas and architectural representation.
- C. Execute the major conventions of architectural drawing representation such as axonometric, isometric, oblique and perspective views.
- D. Execute and understand multiple digital design software.
- E. Compose and present drawings with attention to line weight, character, and accuracy.
- F. Structure and organize elements of design into complete two and three dimensional illustrations.
- G. Utilize necessary analog/digital tools to produce architectural drawings and presentation displays by using multiple media platforms in assigned projects.
- H. Use drawings to explore and diagram design concepts. Student will explore the interrelationship and process of translating design ideas from analog to digital.
- Produce well-crafted presentations that communicate architectonic ideas clearly and effectively for studio presentations.
- J. Execute the major conventions of architectural representation, such as plans, sections, elevations, and other three-dimensional drawings.
