I. Catalog Description

Continuation of the study, methodology, and production of architectural drawings. Exploration of techniques available for the design process with emphasis on three-dimensional composition both analog and digital. Course is intended to fulfill all or part of the following National Architectural Accrediting Board (NAAB) Student Performance Criteria: A.1 Professional Communication Skills; A.5 Ordering System. **Prerequisite: ARCH 1307 with a "C" or better. (2:4). Lab fee.**

II. Course Objectives

Upon successful completion of this course, students will be able to:

- A. Use Three-Dimensional Digital Modeling in various platforms with further exploration of software capabilities.
- B. Investigate color theory and utilize color effectively in design through various analog and digital media.
- C. Use shade and shadow techniques effectively in design; student will have an overall understanding of design orientation and light source.
- D. Create drawings that demonstrate an understanding of design processes and further explore various ways to represent design concepts through various ordering principles.
- E. Compare and interpret the relationship between analog and digital techniques.
- F. Utilize various digital media to create presentations for target audiences within the profession and the general public; select appropriate media techniques for greatest emotional and artistic impact.
- G. Develop a comprehensive design presentation, including plans, elevations, sections, axonometric, perspectives, and appropriate graphics to communicate schematic and design decisions.
- H. Master digital imaging software through graphic design principles and architectural representation and produce quality images and publications suitable for portfolios.

III. THECB Learning Outcomes (ACGM)

Upon successful completion of this course, students will:

- 1. Execute the major conventions of architectural representation of pictorial drawings such as axonometric, isometric, and oblique views.
- 2. Use color effectively in design.
- 3. Use shade and shadow techniques effectively in design.
- 4. Create drawings that demonstrate an understanding of design processes.
- 5. Diagram spatial ideas and clarify design concepts.
- 6. Produce well-crafted presentation materials that communicate ideas clearly.

IV. Evaluation

Project Evaluation will be based on the degree to which the student demonstrates:

- 1. The creative solution to design projects.
- 2. The understanding and execution of design principles.
- 3. The communication skills involved with solutions, including craftsmanship and use of materials and mediums.
- 4. Professional attitude toward design and effort.
- 5. Neatness in presentation and project execution.
