# I. Catalog Description

Effective use of representational media, computer aided design, and digital media to engage formal, organizational, and environmental principles. Emphasis on the appropriate media to inform two-dimensional and three-dimensional design based upon the conventions of architectural graphic communication. Course is intended to fulfill all or part of the following National Architectural Accrediting Board (NAAB) Student Performance Criteria: A.1 Professional Communication Skills; A.4 Architecture Design Skills. (2:4). Lab fee.

#### II. Course Objectives

Prepare the student to focus on developing Computer Assisted Drawings (CAD) and develop the student's 3D modeling skills; understanding techniques to apply those skills to the design process.

Upon satisfactory completion of the course, the student will be able to:

- A. Employ appropriate representational media, including computer technology, to convey essential formal elements of each stage of the programming and design process.
- B. Develop a comprehensive design presentation, including plans, elevations, sections, axonometric, perspectives and appropriate graphics to communicate schematic and preliminary design decisions.
- C. Manage Windows OS to operate programs, and to manage computer folders and files in order to develop design drawings and presentations.

# **III. THECB Learning Outcomes (ACGM)**

Upon successful completion of this course, students will:

- 1. Execute and understand digital design software.
- 2. Produce digital drawings that clearly and accurately communicate design intentions.
- 3. Manage and reproduce digital files.
- 4. Compose and present drawings with attention to line weight, character, and accuracy.
- 5. Compare and interpret the relationship between analogue and digital techniques in the design process.
- 6. Produce quality images and publications suitable for portfolios.
- 7. Recognize various digital media used to create presentations for target audiences within the profession and the general public.
