I. Catalog Description

A studio art course that introduces the materials, processes, and concepts pertaining to traditional and contemporary printmaking. The course explores the use of varied tools and techniques along with the formal and conceptual principles to create editioned and unique works. Introduces the basics of relief, intaglio, and lithographic printmaking techniques including the terminology and brief history of these processes. (2:4). Lab fee.

II. Course Objectives

Upon satisfactory completion of the course, the student will be able to:

- A. Identify equipment, processes, and materials used in printmaking beginning with a drawing and culminating in a final print.
- B. Draw, etch, and print a finished lithograph based on demonstrations provided by the instructor.
- C. Draw, etch and print a finished intaglio image based on demonstrations provided by the instructor.
- D. Draw, carve, and print a finished relief image based upon demonstrations provided by the instructor.
- E. Use critical thinking skills to evaluate visual content in a group and/or individual classroom setting.

III. THECB Learning Outcomes (ACGM)

Upon successful completion of this course, students will:

- 1. Apply the basic elements and principles of visual art as they relate to the discipline of printmaking.
- 2. Differentiate traditional print mediums of intaglio, relief, lithography, and serigraphy.
- 3. Analyze and critique printed works verbally and/or in writing.
- 4. Employ discipline-specific vocabulary in the evaluation of traditional and contemporary printmaking.
- 5. Relate printed works to historical and contemporary developments in the field.
- 6. Demonstrate an appropriate level of professional practice, including safety, craft, and presentation.

There is no pre-assessment for this course.

There is no challenge exam for this course.

C. Post-assessment

Each student's grade will be determined by the instructor upon successful completion of the course objectives. Instructors will maintain adequate records of student progress according to the guidelines established by the college.
