I. Catalog Description

Study and application of the methods and components of theatrical production that may include one or more of the following: theater facilities, scenery construction and painting, properties, lighting, costume, makeup, sound, and theatrical management. Participation in the stagecraft aspects of production is required for all students registered for this course. Prerequisite: Placement at college-level English Language Arts Reading by TSIA2 or equivalent; OR completion with a "C" or better or concurrent enrollment in the following: INRW 0311 or INRW 0312 or ESOL 0340. (3:0).

II. Course Objectives

Upon satisfactory completion of this course, the student will be able to:

- A. Have an awareness of the technical problems of play production and employ practical skills for solving design to stage problems.
- B. Recognize and follow production organization and management protocols.
- C. Develop and practice backstage safety protocols applicable to rigging, lighting, and scenery construction.
- D. Demonstrate basic knowledge and applied use of tools and materials for scenery construction and properties.
- E. Recognize and demonstrate production techniques for drop, flat, and platform construction.
- F. Recognize and demonstrate scenic painting techniques.
- G. Recognize and demonstrate electrical theory, including basic theater lighting techniques.
- H. Demonstrate the ability to read and hang a light plot.
- I. Have an awareness of how to integrate and synthesize all aspects of play production including scenery construction, lighting design, and costume and makeup design.
- J. Critically evaluate in writing the production/performances of the EPCC Theater department.
- K. Demonstrate critical thinking and problem-solving skills.

III. THECB Learning Outcomes (ACGM)

Upon successful completion of this course, students will:

- 1. Apply a vocabulary and knowledge of the environment, tools, and skills required to mount a theatrical production.
- 2. Demonstrate knowledge of the variety of work required to mount a theatrical production.
- 3. Describe the collaborative nature of production within theater arts.

IV. Evaluation

- A. As part of the integrated lecture/lab course, students are required to work at least 50 hours at the Transmountain Forum theater on a major production project. Students will be evaluated on both the quality of their work and the completion of the required 50 hours. Students will apply, demonstrate, and practice their mastery of stagecraft course objectives.
- B. Students will work in conjunction with other students on a final production project. Evaluation of this project will focus on the actual hands-on experience involving the student's knowledge and skill in stagecraft work and the work product itself. The work product will be used in an actual EPCC production.
- C. Students are required to attend EPCC productions and submit 2 criticism papers evaluating the production elements.
- D. Essay, multiple choice, fill-in-the-blank, oral or small group exams/quizzes may be used to evaluate understanding of the basic concepts and ideas covered in the text and classroom lectures.
