#### I. Catalog Description

A health-related work-based learning experience that enables the student to apply specialized occupational theory, skills, and concepts. Direct supervision is provided by the clinical professional. A grade of "C" or better is required in this course to take the next course and/or for this course to be eligible for "course completion" credit or eligibility to take licensing exam. Prerequisites: EMSP 1160 and EMSP 1161 and EMSP 1356 and EMSP 1438 and EMSP 1501. Corequisite: EMSP 1355. (0:5). Professional Practice Insurance required.

## II. Course Objectives

Upon satisfactory completion of this course, the student should be able to:

- A. Perform patient assessments, complete and accurate examinations based on the patient's chief complaint and the mechanism of injury.
- B. Utilize knowledge of kinematics, pathophysiology principles, assessment, and assessment findings to formulate a field impression, prioritize, and provide appropriate care and management for the patient with trauma.
- C. Manage an airway and provide respiratory support.
- D. Select, prepare, and administer selected medications.
- E. Perform scene assessment and coordinate scene management that provides for scene safety, emergency care, and light extrication and transport.
- F. Observe, assist, and participate as a team member in multiple casualty incidents as assigned, including triage.
- G. Observe, assist, and participate as a team member in rescue operations as assigned.
- H. Observe, assist, and participate as a team member in hazardous material incidents, as assigned.
- I. Observe, assist, and participate as a team member at potentially violent situations, as assigned, utilizing evasive tactics, concealment techniques, and field "contact and cover" procedures during assessment and care.
- J. Adhere to safety practices.
- K. Report and record pertinent scene/patient information in a concise, accurate, and objective manner.
- L. Relate patient/scene information in written and verbal forms.
- M. Demonstrate cognitive and skills competency of all previous program objectives a the appropriate level of registry/certification and level of study defined by State of Texas, TDH, and NHTSA-DOT.

# III. THECB Learning Outcomes (WECM)

As outlined in the learning plan, apply the theory, concepts, and skills involving specialized materials, tools, equipment, procedures, regulations, laws, and interactions within and among political, economic, environmental, social, and legal systems associated with the occupation and the business/industry and will demonstrate legal and ethical behavior, safety practices, interpersonal and teamwork skills, and appropriate written and verbal communication skills using the terminology of the occupation and the business/industry.
