## I. Catalog Description

A survey of world literature from the seventeenth century to the present. Students will study works of prose, poetry, drama, and fiction in relation to their historical and cultural contexts. Texts will be selected from a diverse group of authors and traditions. All selections are read in English translations. ENGL 2332 is not required in order to enroll in ENGL 2333. **Prerequisite: ENGL 1301 with a "C" or better. (3:0).** 

## II. Course Objectives

Upon satisfactory completion of this course the student will be able to accomplish the following:

- A. Demonstrate **personal responsibility skills** including the ability to connect choices, actions and consequence to ethical decision-making and explain the relationship between authors and their works in the context of their historical, social, and philosophical issues during the corresponding time periods.
- B. Identify major trends of thought and literature in each period studied.
- C. Engage in **critical thinking skills,** creative thinking, innovation, and inquiry, and demonstrate analysis, evaluation and synthesis of information of each literary figure studied.
- D. Define literary terms and explain their practical application.
- E. Demonstrate **social responsibility skills** including the ability to work with others to support a shared purpose or goal regarding intercultural competence, knowledge of civic responsibility, and/or the ability to engage effectively in local, regional, national, and/or global communities as presented in the literature considered.
- F. Demonstrate effective written, oral, and/or visual **communication skills** through the successful writing of critical essays, research papers, journals, or a combination of these.
- G. (Recommended) Attend and evaluate at least one interpretive performance of a piece of literature from the period, i.e., poetry reading, play, film, etc.

#### **Course Organization:**

Unit titles will be determined by the instructor. Approaches may include but are not limited to the following:

- A. A.D. 1650 to 1800
- B. 1800 to 1900
- C. 1900 to the present

## III. THECB Learning Outcomes (ACGM)

Upon successful completion of this course, students will:

- 1. Identify key ideas, representative authors and works, significant historical or cultural events, and characteristic perspectives or attitudes expressed in the literature of different periods or regions.
- 2. Analyze literary works as expressions of individual or communal values within the social, political, cultural, or religious contexts of different literary periods.
- 3. Demonstrate knowledge of the development of characteristic forms or styles of expression during different historical periods or in different regions.
- 4. Articulate the aesthetic principles that guide the scope and variety of works in the arts and humanities.
- 5. Write research-based critical papers about the assigned readings in clear and grammatically correct prose, using various critical approaches to literature.

#### IV. Evaluation

#### A. Pre-assessment

Instructors should check each student's prerequisites the first week of class; those who do not qualify should be sent back to Admissions.

#### B. Post-assessment

- 1. The instructor will maintain a continuous record of each student's progress.
- 2. Students should be evaluated periodically throughout the semester.
- 3. The instructor will determine the weight of each graded assignment.
- 4. Instructors will require writing assignments other than quizzes and formal exams.
- 5. Plagiarism is both intellectual theft and academic dishonesty and will not be tolerated. Any work that is plagiarized could result in failure of the course. See the Student Handbook.

#### C. Remediation

This is left to the discretion of individual instructors. Some instructors permit students to re-write major writing assignments. Students needing assistance with writing problems are encouraged to contact the instructor.

The centers' goal is to help students grow and improve as writers during any stage of the writing process.
