## I. Catalog Description

Study of the pathology and general health management of diseases and injuries across the life span. Topics include etiology, symptoms, and the physical and psychological reactions to diseases and injuries. **Prerequisites: BIOL 2401 and BIOL 2402. (3:0).** 

### II. Course Objectives

Upon satisfactory completion of this course, the student will be able to:

- A. Explain in general terms, the structure, physiology and energetics of the generalized a animal cell.
- B. Define cellular adaptation and describe the different types of cellular adaptation.
- C. List and briefly describe the different mechanisms of cell injury.
- D. Describe the process of tissue repair and wound healing.
- E. Describe the genetic control of cell structure and function. Compare and contrast the different patterns of inheritance.
- F. Identify the most common genetic, chromosornal and congenital disorders and their clinical manifestations.
- G. Describe the process of cell growth and reproduction and their relationship with the process of oncogenesis. Compare and contrast benign versus malignant neoplasias and discuss the proposed etiologic factors of cancer as well as the therapeutic possibilities.
- H. Identify and describe the normal physiology and the pathophysiology of the most common alterations of the following processes and body systems:
  - 1. Inflammation, immunity and lymphatic system.
  - 2. Integumentary system.
  - 3. Cardiovascular system (Blood, heart and blood vessels)
  - 4. Respiratory system.
  - 5. Fluids, electrolytes and acid-base balance.
  - 6. Urinary system.
  - 7. Endocrine system
  - 8. Nervous system.
  - 9. Musculo-Skeletal system.
  - 10. Male and female reproductive systems.

Upon successful completion of this course, students will:

- 1. Distinguish environmental factors, physical, psychosocial, and cognitive characteristics of various diseases and conditions.
- 2. Identify implications of therapeutic interventions for diseases and conditions.
