I. Catalog Description

Continues performance in a wide variety of music in the popular and contemporary idioms. Stresses improvisation techniques and interpreting various jazz styles. Open to woodwind, brass, and rhythm instrumentalists. **Prerequisite: MUEN 1137. (0:3).**

II. Course Objectives

Upon satisfactory completion of the course, the student should develop musical competence in:

- A. Participate in public performances of jazz and popular chamber music.
- B. Perform music with appropriate interpretation and style.
- C. Demonstrate technical proficiency with the instruments played.
- D. Demonstrate skills in improvisation.
- E. Demonstrate principles of stage performance and behavior appropriate to jazz ensemble music.

III. Evaluation

Course evaluation is based on appraisal by the instructor of:

- A. Attendance and cooperation required at ALL performances and rehearsals.
- B. Application of principles of ensemble performance: intonation, rhythmic accuracy and interpretation.
- C. Application of the above principles and behavior in performances.
- D. Attendance. The final grade will be determined as follows:
 - 1. If a student misses a performance their final grade will be lowered by two letter grades.
 - 2. The student's grade will be lowered by a letter grade for every unexcused absence from a rehearsal starting with the third absence. After six unexcused absences, the student's grade will result in an F.
 - 3. Tardiness can result in the lowering of the daily grade and will be left up to the discretion of the instructor.
- E. Since there are no written assignments or formal tests in jazz ensemble, a policy on makeup of work is not applicable.
